# **UPDATES - Management**

### **Property Improvement Project**

We are approaching the end of the major construction work with the siding, insulation, windows, doorwalls, front doors, storm doors and 2 bedroom bathroom frozen pipe improvements. As we do, please know that each building will undergo yet another 360 degree exterior inspection, with inspections performed by Marcus Management, Rocket Exteriors, and our staff. We will develop a punch list of items that will begin the close-out of the contract with Rocket. Members are encouraged to report exterior items as well. In terms of interior items, we will be passing out an inspection survey report so that you will have a standardized form to submit any remaining interior items inside your home that may need attention. When you receive your survey form, please complete it and turn it into the office, even if you do not have any remaining items needing attention. We wish to receive a survey form from each and every member.

As we close out the contract, please know that there is a 5 year warranty that begins once the project is substantially complete. The project is substantially complete when all punch list items have been completed. So, we do wish for all survey forms to be returned in a timely fashion so we can create the final punch list of items and provide it to the contractor. Final payment to the contractor (over \$200,000.00) will not be made until all repairs have been completed.

Reporting of any of the construction issues associated with this improvement program are to be provided to Ralph Marcus at a construction or by calling the Arrowwood Hills Office, and staff will forward your concerns to Mr. Marcus.

### Staffing/Hiring

**Site Manager:** The Board has screened applications and is setting up interviews with top candidates.

**Maintenance technician:** Arrowwood management has interviewed for the position and selected a candidate. Management is in the process of completing the background check and checking references.

**Wanted:** Seasonal grounds people. Arrowwood is looking to hire interested members to do seasonal work. Seasonal workers will assist with the maintenance of outside areas of the property (completing grounds work orders, repainting parking lot numbers, etc.). Must be 18 years of age or older. Applications can be emailed to or or dropped off at the office.

# Fostering Member Participation & Democratic Decision-Making

### Importance of Member Participation

The strength of a housing cooperative lies in the active involvement of its members. By participating in cooperative affairs, members become active stakeholders, sharing responsibilities, and contributing to the vibrant community life. Through member participation, housing cooperatives flourish as dynamic and inclusive spaces. Diverse perspectives enrich discussions, leading to well-rounded decisions that consider the interests and needs of all members.

# Roles and Responsibilities of Cooperative Members

Members shoulder essential roles and responsibilities that contribute to the community's well-being. Beyond being residents, they actively engage as co-owners, board members, committee participants, and volunteers. As co-owners, members share the responsibility of maintaining the property, paying cooperative fees, and ensuring the cooperative's financial sustainability. Board members play a crucial leadership role, overseeing operations and making decisions on behalf of the community. Committee participation allows members to contribute their expertise and interests to various areas, such as maintenance, finance, or social events.

#### **Democratic Decision-Making Processes**

Cooperatives operate as self-governing entities, with decisions made collectively and transparently. Democratic decision-making ensures that each member has a voice in shaping policies, making financial choices, and determining the cooperative's overall direction. Emphasizing inclusivity and consensus building, this approach strengthens community ties and encourages a culture of respectful communication and mutual understanding.

### How to Engage in Cooperative Affairs

# **BYLAWS BULLETIN**

Welcome to the first installment of our series on the By-Laws Bulletin. Each month we will list one of the by-laws and explain its meaning. The first bulletin is related to the membership certificates.



Article 3. Section 5 Membership Certificates. Each membership certificate shall state that the Corporation is organized under the laws of the State of Michigan, the name of the registered holder of the membership represented thereby, the Corporation lien rights as against such membership as set forth in this Article, and the preferences and restrictions applicable thereto, and shall be in such form as shall be approved by the Board of Directors. Membership certificates shall be consecutively numbered, bound in one or more books, and shall be issued there from upon certification as to full payment. Every membership certificate shall be signed by the President or Vice President, and the Secretary or Assistant Secretary, and shall be sealed with the corporate seal.



### What does this mean?

Arrowwood Cooperative is a member-owned cooperative. As members, we collectively own the corporation that is Arrowwood Hills Cooperative but do not own our individual units outright. Each member of the cooperative is a shareholder and the membership certificate is a certificate of stock or share in the corporation; the certificate is proof that you are a registered owner of an equal share of stock in the corporation.

According to the by-laws, Arrowwood is responsible for making sure that every member is in possession of a membership certificate that is signed by the board president and secretary. Some members are in possession of a membership certificate while other members are not. Management and office staff are putting together a plan to complete the distribution of the certificates.
